# CITY OF EDGERTON POLICE COMMISSION MEETING MINUTES Tuesday, December 26, 2023

President Mark Coombs called the meeting to order at 5:30 pm. Commission Members in attendance were Mark Coombs, Jim Davis, Terry Dickinson, Joshua Lee and Lisa Venske. Also attending was Police Chief Kowalski and Lieutenant Fellmeth. This meeting was held in person at City Hall and live streamed.

Coombs confirmed the agenda was posted properly for this meeting at City Hall, the Library, the Post Office, as well as online on the City of Edgerton website on Thursday, December 21, 2023.

#### **MINUTES:**

Lee/Davis motion to approve the December 21, 2022 Police Commission Meeting Minutes passed, all in favor.

CHIEF'S REPORT: Edgerton's Police Department is doing well. Newest Officer M Buescher one year anniversary is up on January 16, 2024. Deputy Chief position and procedure for approval was discussed. A replacement squad car was reported and is in progress. Annual Report will be released soon. PD budget has been approved. All training requirements are up to date and future opportunities are in progress. Chief continues to update the Commission via email on a regular basis.

Police Commissioner Davis commended School Resource Officer Brody for his outstanding work and willingness to fill in wherever needed at the schools. Thank you, Officer Brody.

### **CLOSED SESSION:**
