**ELECT PUBLIC JOINT REVIEW BOARD MEMBER**: A Burdick/Wehner motion to nominate Jon Paulson as the public Joint Review Board member passed on a 4/0 roll call vote.

**MINUTES:** A Burdick/Towns motion to approve the November 15, 2023 Joint Review Board minutes passed on a 4/0 roll call vote.

# RESOLUTION APPROVING COMMON COUNCIL RESOLUTION CREATING TAX INCREMENTAL DISTRICT NO. 12 CITY OF EDGERTON, WISCONSIN

WHEREAS, the Joint Review Board, Tax Incremental District No. 12 (TID # 12), City of Edgerton, Wisconsin, has reviewed the public record, planning documents and resolution of the Edgerton Common Council related to TID # 12; and

WHEREAS, the Joint Review Board, TID #12, City of Edgerton, Wisconsin, has received in an open meeting additional information from the City of Edgerton regarding TID #12.

**NOW, THEREFORE, BE IT RESOLVED** that pursuant to Wis. Stat. §66.1205(4m)(c), the Joint Review Board finds:

- 1. The development expected in TID #12, City of Edgerton, Wisconsin, would not occur without the use of tax incremental financing, and in the Board's judgment the development described in the documents the Board has reviewed would not occur without the creation of a tax incremental district;
- 2. The economic benefits of TID #12, City of Edgerton, Wisconsin, as measured by increased employment, business and personal income, and property value, are sufficient to compensate for the cost of the improvements;
- 3. The benefits of the proposal outweigh the anticipated tax increments to be paid by the owners of property in the overlying taxing districts.

**BE IT FURTHER RESOLVED**, the resolution of the Common Council creating TID #12 is hereby approved by the City of Edgerton Joint Review Board.
