
Funds are Limited!

The City of Edgerton has grant funds available for housing rehabilitation through a Community Development Block Grant. These funds will be loaned at 0% interest to eligible households for home repairs. Applications are accepted on a first-come first-serve basis. There is no cost to fill out an application, and all information submitted is strictly confidential.

FOURTH QUARTER

Funds will be lent to eligible households for home repairs. Households must meet the income limits listed here to be eligible. The loan is a 0% interest, deferred payment loan: you do not pay it back until you sell the house or no longer live there. After 30 years, your loan will be reviewed with the possibility of extending it for another 30 years.

2017 Sewer Rates

The Edgerton Utility Commission recently completed a financial forecasting project for the water and sewer utilities. The forecast considered components that affect utility rates—such as existing debt, future projects, operating costs, and increased revenues through growth in the City—to determine how best to ensure that quality and safe services are provided most cost effectively.

Using this information, the Commission recommended that the City Council implement an inflationary rate adjustment for 2017 for the sewer utility only. The City Council agreed with the Utility Commission's recommendation and approved a 3% rate increase for the sewer utility. Starting with the first quarter bill in 2017, these rates will result in an increase in the quarterly charge for the average residential user (12,000 gallons/quarter) of \$3.83 and an increase of \$5.59 for large residential users (20,000 gallons/quarter).

PUBLIC WORKS NOTICES

Winter Parking Rules: Winter snow parking regulations went into effect on November 1st. Parking is not allowed on any street or highway after any snowfall until snow is plowed back to the curb. Overnight parking in parking lots is restricted to the rear of the lots during any snowfall as posted in all lots.

Sidewalks: Please have your sidewalks cleared of snow and ice from edge to edge no later than 24 hours after a snowfall. Failure to clear walks in the appropriate time may result in a fine of \$25.00-\$200.00. Please do not shovel snow into the street.

Christmas Trees: Starting January 3, 2017 and every Monday thereafter through January, the Public Works Department will pick up Christmas trees placed at the curb.

UTILITY NOTICES

Winter Vacations: Please consider shutting off your water in the basement if you will be out of town this winter. Shutting off water could prevent damage (and a large water bill) if you have plumbing problems while you are gone. Water cannot be shut off to some appliances, so make sure you review the requirements of your water-using appliances before you shut off the

Snow Around Fire Hydrants: The Edgerton Water Utility and the Edgerton Fire Protection District encourage residents to clear snow away from fire hydrants that are located near their property. Having easy access to fire hydrants will save precious time if the hydrant is needed to fight a fire. Your assistance is greatly appreciated.

DOG AND CAT LICENSES

Dog and cat licenses expire on December 31, 2016. Please renew your pet's license before March 31, 2017 to avoid a \$5.00 late fee. Proof of rabies vaccination is **required** by the County in order to obtain a license. If you do not have a copy of the animal's vaccination record, contact your veterinarian for a duplicate copy.

PROPERTY TAXES

Taxes for City of Edgerton Residents in Rock County can be paid in the Treasurer's Office at the Rock County Courthouse in Janesville. Dane County residents within the City of Edgerton can pay taxes at the Edgerton City Hall.
