Police Radio Upgrades: The Edgerton Police Department has applied for a grant to replace the 20-year plus radios currently being used by the Department. The Wisconsin Department of Military Affairs (DMA) through the FY2025 Interoperability Radio Grant Program is offering the grant. The intent of this grant is to assist local government agencies with purchasing radios and equipment needed to transition operations from the existing VHF WISCOM system to the new 7/800 MHz WISCOM system.

To qualify for this grant, a municipality must provide a resolution (attached) or other written commitment from the local unit of government's governing body indicating the local unit of government's intention to pay for 20 percent of the total grant awarded. A one-time reimbursement of 80% of the total cost for the radios will occur when closeout materials are submitted to the DMA. Funding for the radios will be available from a reduction in health insurance costs due to staffing changes in the Police Department.

Three quotes for the radios were obtained and BANDT Communications can provide the radios that best meet the requirements and needs of the department.

- * BANDT Communications Kenwood VP8000 radios \$45,486.90
- * GenComm Communications Kenwood VP8000 radios -\$57,160.56
- * Baycom, Inc. Motorola APX-NEXT Portable radios \$109,590.60

Surplus Leaf Vacuum: Staff is requesting to surplus the leaf vacuum. The leaf vacuum has not been in service for several years due to mechanical problems. There will be no change to the leaf collection operations by auctioning the leaf vacuum. Staff recommends a \$200 minimum bid be set.

Tri County Community Center Backdoor Grant: Tri County Community Center is seeking a grant to purchase four replacement windows on the back side of the building and to pressure wash the front and side of the building. The white, vinyl windows will fill the existing openings and have grills to mimic the existing windows. The windows will be installed by Ridge Top Exteriors. The window bid is \$11,919.46 and the pressure washing bid is for \$795.

Policy questions include:

- Does this qualify as a Backdoor Grant? If it does, then the windows alone will exceed the maximum grant amount the award of \$5,000 and the award would not have to include the pressure washing. If the RDA determines that this is not a Backdoor Grant but instead an Exterior Improvement Grant, then the grant amount for the windows, not including the pressure washing, would be \$4,767.78
- Is pressure washing grant eligible or is this a maintenance item? The program policy does not anticipate
 pressure washing as an eligible expense.
- Is the RDA comfortable with funding a project that does not include installation?
- The applicant has applied for three grants. The current policy using the Limited ED funds is that only one grant is allowed per year. Now that the new TIF is in place, which can provide more funding, does the RDA wish to remove the one grant per year restriction on the Limited ED fund? There is approximately \$50,000 remaining in the Limited ED Fund.
- The applicant has asked for two different grants for window replacement. Should the window replacement be considered one grant and will the RDA allow the applicant to split the project to allow for two grant applications.

Tri County Community Center Exterior Improvement Grant: Tri County Community Center is seeking a grant to remove a tree and to purchase two replacement windows for the front side, first floor and a third on upper floor. The white, vinyl windows will fill the existing openings and have grills to mimic the existing windows. The windows will be installed by Ridge Top Exteriors. The window bid is \$11,472. The maximum grant for the windows is \$4,589.08. The application also requested funding to remove a tree on the south side of the building for \$3,675. If the tree removal is program eligible, the maximum grant would be \$5,000.

Policy questions include:

- Is tree removal grant eligible? The program policy does not anticipate tree removal as an eligible expense.
- Is the RDA comfortable with funding a project that does not include installation?
- Can the applicant apply for more than one grant. (See discussion above)

Tri County Community Center Interior Improvement Grant: Tri County Community Center is seeking a grant to put a new electrical service panel on the first floor and remove the current box that is in a basement tunnel. The bid for the project is \$25,909. The maximum grant for the work is \$3,000.

Policy questions include:

The petitioner is granted approval of a final Certified Survey Map and that the actual boundary of the rezoned area coincide with the final CSM boundary.
